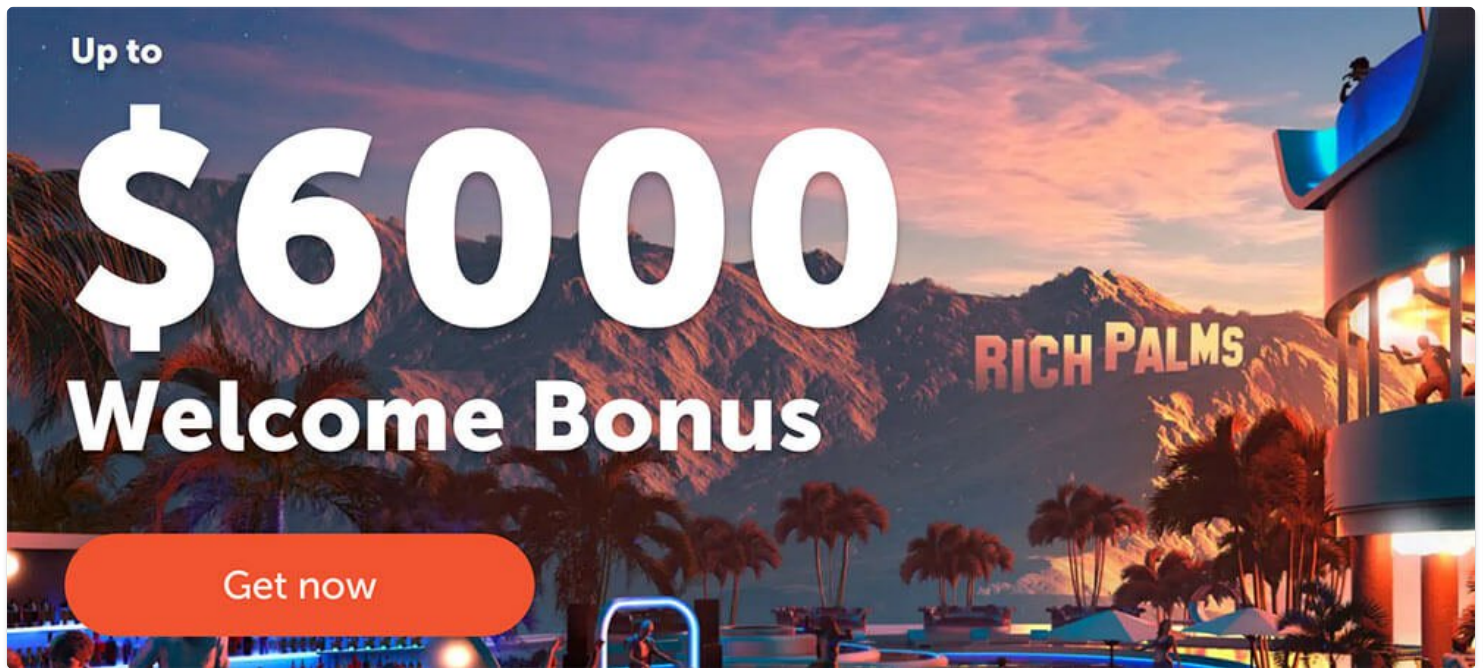

Sites displaying seals from these certifiers show accountability; without this, you should be cautious.

Security and Encryption
